INMP Grower Self-Certification FAQs

When will I know if I passed the test?

As soon as you complete the test, you will receive your results. To pass, you will need a score of 24/30 or higher (80%).

When will I receive my letter of eligibility?

Your letter of eligibility to self-certify INMP worksheets will be sent to the registered email address within 5 business days after the completion of the exam. **PLEASE PRINT YOUR LETTER OF ELIGIBILITY AND KEEP IT WITH YOUR COALITION MEMBERSHIP RECORDS.**

How long am I eligible to self-certify INMP worksheets?

You are eligible to self-certify INMP worksheets until the date listed in your letter of eligibility. Eligibility certificates expire on a 6-month cycle. See table below for details.

How do I renew my eligibility?

In order to renew your eligibility to self-certify INMP worksheets, you must complete 3 hours of approved continuing education prior to the expiration date listed in your letter of eligibility.

What are my options for Continuing Education?

webinars available, as well as self-study options that you can complete at your own pace. The self-study option does require a post-test to ensure you viewed the materials.

After you complete a continuing education course, you will receive a record of course completion by email with the number of hours you completed. **PLEASE PRINT YOUR RECORD OF COURSE COMPLETION AND KEEP IT WITH YOUR COALITION MEMEBERSHIP RECORDS.**

What if I don't get the 3 hours of continuing education by the expiration date?

If you do not obtain 3 hours by the date listed in your letter of eligibility, your eligibility to self-certify will expire. This will require you to take the self-certification training and pass the exam again in order to continue self-certifying your INMP Worksheets.
