



"The Beginning of the End" for the ILRP in the Pit River

The February 21, 2025 Regional Board informational hearing on the Pit River was "the beginning of the end" as the expression goes. While the unanimous direction from the Board to exempt the Pit River irrigated agriculture from the Irrigated Lands Program was something Coalition leadership feels should have come sooner, the Regional Board was deliberate and thorough to ensure it was done correctly. Discussions to revise the Sacramento Valley Water Quality Coalition Waste Discharge Requirements (WDR) exempting the Pit River will begin with hopes of finalizing the exemption at the June 19-20 Board meeting.

This is a huge milestone. It was only possible through the commitment of Pit River farmers/ranchers, UCCE, and many others to sharing with the Regional Board that Pit River irrigated agriculture's stewardship practices are protective of water quality.

In Memory of Pam Giacomini

A Virtuous Life of Ardent Devotion

It was a briskly cold March morning on the Modoc Plateau in 2009 when I first met Pam Giacomini at the Northeastern California Water Association's (NeCWA) sixth annual membership meeting. Her affable personality immediately warmed up the room.

Over the next 16 years I would get to know her as a champion of ranching and agriculture, share with her stories about serving the community as an elected official, and count on her to be a sounding board on advancing an alternative Irrigated Lands Regulatory Program for the upper watersheds of the Sacramento Valley.



What I came to appreciate about Pam was something already well-known to others who worked closely with her—like David Guy who worked with her for years, and known to the North State Agricultural Commissioners, for whom she hosted an annual barbeque at the Hat Creek Grown cattle operation she managed with her husband, Henry. This was simply Pam: a person whose life was defined by service, devotion, and an unwavering commitment to excellence in everything she pursued.

This devotion to farming, ranching, and the rural way of life, led to her being recognized in 2016 as a recipient of the Common Threads North Award bestowed on women in agriculture who have chosen to make a difference in their communities and our world through philanthropy and service. The award honors those exemplary individuals whose extraordinary contribution of time, energy and resources enhance the lives of all around them. For Pam, this award was well deserved!

She was an integral part of Hat Creek Grown in Shasta County, where Henry and she raise more than 1,000 head of beef cattle. They were selected as one of three finalists for the 2024 California Leopold Conservation Award® which honors farmers, ranchers, and forestland owners who go above and beyond in their management of soil health, water quality and wildlife habitat on working land.

We will all miss Pam, and we hope we can carry her devotion and spirit forward to make the Sacramento Valley a better place!
